Likewise, there was a decrease of FRW5.00 against EUR. Unlike against the Pound, the FRW increased by FRW0.09.

Continued pressure is expected on the USD:FRW as FX demand remains the dominant driver.

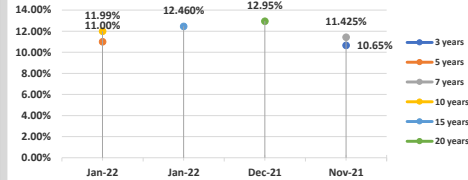
