## FOREIGN EXCHANGE RATE

FRW slipped further on Friday, by FRW0.23 against USD.

However, against EUR and GBP, the FRW strengthened by FRW0.04 and FRW1.42 respectively.

Continued pressure is expected on the USD:FRW as FX demand remains the dominant driver.

The Repo rate was 6.00% and the total funds traded were FRW10.0bn against the previous of FRW30.0bn.

The 10 Year Government Treasury Bond Reopening of FRW35.0bn has been priced at discount with a yield of 12.149% and the coupon rate remains at 12.15% p.a.

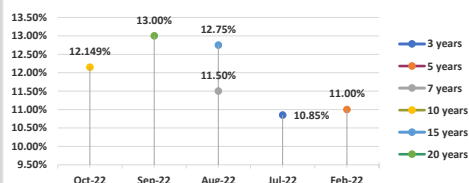
